Comprehensive general liability insurance with carriers authorized to do business in the State of New Mexico and with policies remaining in full force and effect during the period of time contemplated by the permit, covering premises, products/completed operations, independent contractors, contractual coverage, advertising injury and protection against claims for all damages arising from bodily injury, property damage, and personal injury, including death, related to the activities to be undertaken in the City.

1. A Certificate of liability insurance naming LUNA COUNTY, along with its elected and appointed officials, employees, officers, agents, volunteers, boards, commissions, representatives, professionals, and insurers as additional insureds with limits carried of at least \$1,000,000.00 per occurrence with a \$2,000,000.00 aggregate underwritten by an insurance company licensed to do business in the State of New Mexico and acceptable to Luna County. All such policies of insurance shall indicate that they are primary and non-contributory and shall include a waiver of subrogation or transfer of rights.

For individuals:

A certificate of liability insurance with personal liability covered under a homeowners or similar insurance policy including bodily injury and property damage with minimum limits of liability not less than \$1,000,000.00 naming Luna County as additional insured.

The County may impose additional requirements prior to the issuance of this permit. The County reserves the right to revoke this permit if unforeseen circumstances make this necessary. Please check payable to Luna County Film Office.
